

## ORDINANCE NO. 1087

AN ORDINANCE OF THE CITY OF BELLEVILLE, KANSAS, ADOPTING THE "NEIGHBORHOOD REVITALIZATION PLAN FOR REPUBLIC COUNTY, KANSAS, JANUARY 2026" AND AUTHORIZING ENTERING INTO AN INTERLOCAL AGREEMENT FOR THE ADMINISTRATION OF THAT PLAN.

WHEREAS, Republic County, Kansas, pursuant to K.S.A. 12-17,114 *et seq.* (the "Kansas Neighborhood Revitalization Act"), has adopted a plan to assist in the rehabilitation, conservation or redevelopment of an area within Republic County described in the Neighborhood Revitalization Plan for Republic County, Kansas, January 2026 (the "Plan").

WHEREAS, the Governing Body may, pursuant to the Kansas Neighborhood Revitalization Act, also adopt a neighborhood revitalization plan to assist in the rehabilitation, conservation or redevelopment of any area within the City.

WHEREAS, the Governing Body has determined that the Plan complies with the Kansas Neighborhood Revitalization Act, and that rehabilitation, conservation or redevelopment of the neighborhood revitalization area identified in the Plan is necessary to protect the public health, safety or welfare of the residents of the City.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BELLEVILLE:

Section 1. Finding. The Governing Body has reviewed the "Neighborhood Revitalization Plan for Republic County, Kansas, January 2026" as adopted by the Republic County Board of County Commissioners (hereafter the "Plan"), and finds and determines that the property within the City which lies within the Neighborhood Revitalization District, as set out in Exhibit A to the Plan, meets the definition of "neighborhood revitalization area" in K.S.A. 12-17,115(c).

Section 2. Plan Adoption. The Plan is hereby adopted and incorporated by reference as if fully set out herein in accordance with the provisions of K.S.A. 12-3301:3305.

Section 3. Interlocal Agreement. The Mayor is authorized, on behalf of the Governing Body, to enter into an interlocal agreement with Republic County, Unified School District No. 109, Unified School District No. 426, and the cities of Agenda, Belleville, Courtland, Cuba, Munden, Narka, Republic, Scandia, as necessary to implement the Plan, as provided for in K.S.A. 12-17,119.

Section 4. Authority. This ordinance is adopted under the authority of K.S.A. 12-17,114 *et seq.*, K.S.A. 12-3301 *et seq.*, K.S.A. 12-2901 *et seq.*, and Article 12, Section 5 of the Kansas Constitution.

Section 5. Effective Date. This ordinance shall take effect and be in force from and after its adoption and publication in the official city newspaper.

Section 6. Repeal. Ordinance No. 963 and all subsequent amendments thereof, are hereby repealed.
